SECTION 10, Del City Charter: The mayor or any three (3) or more council persons may call special meetings of the council by filing a call in writing with the city clerk. The city clerk shall mail by registered, certified or similar special mail a copy of the call or a written notice thereof to every member of the council not signing the call, at least two (2) days before the meeting; or shall deliver it or have it delivered, in person to each such member, or leave it, or have it left, in a conspicuous place at his or her usual place of residence, at least three (3) hours before the time for the meeting. If all members of the council are present at a special meeting, it shall be assumed that the meeting was properly called; and the legality of the call may not be challenged.
