All applications must be completed in full, including all required supporting documentation. Incomplete applications may be returned to the applicant, leading to substantial delay in processing.

Be sure to read these instructions carefully before proceeding!

Application Form:

1. Be sure to complete the form in its entirety.
2. The project description should be as specific as possible.
3. Square Footage refers to the entire building in / on which the work is to be completed.

Submission Requirements:

A site / plot plan is required, showing the location of the proposed miscellaneous/accessory structure along with all structures on the lot. Distances to property lines and structures must be shown. Two (2) paper copies and one (1) electronic copy of specifications and of drawings drawn to scale with sufficient clarity and detail to indicate the nature and character of such work.

Contractors:

1. Contractors engaging in electrical, mechanical, and plumbing work must hold valid state and city licenses.
2. Permits are obtained directly by the Contractor and Contractors must call for inspection.
3. Permits shall be obtained for all of the electrical, plumbing, related utility connections and heating work.

Special Considerations:

1. **Draining of Pool:** Waste water shall be disposed of in a public sanitary sewer system when available or may be disposed of on the yard in which the pool is located; however, **all waste water disposed of in this manner shall be contained on and restricted to the pool owner's property.** All other methods of disposal of said waste water shall require the approval of the building inspector.
2. **Applicant is responsible for securing any and all approvals from the County or State Health Department.**
